- **Print and Sign forms (if required)-** *Student signature is not required if uploaded to MyCWU portal and information is for the student only. If your spouse is included on this form, they **must print form and provide handwritten signature**. **Important:** To be eligible for federal aid, you, the student, and all contributors are required to consent and approve data sharing and importing income/tax information from the IRS to the FAFSA form. This includes your spouse (if married) or your parent/s (if you are a dependent student). When using the Federal Tax Information (FTI) transfer, most cases do not require further documentation. Even if data sharing and import are unsuccessful or student/spouse/parents filed taxes separately in 2022, all must provide consent to be eligible for Federal aid.
