<u>Call To Order</u> Steven Ross calls the meeting to order at 5:04 p.m.

- Gail Farmer
 - o Presentation about Wellness Center and budget.
 - o 10 student staff and 3 professional staff.
 - o 4 pillars:
 - Reduce negative consequences associated with the use of AOD
 - Mike Who is a license mental health practitioner?
 - Gail Only me so legally I'm the only one who can legally withhold information
 - Richard We do have confidentiality agreements that all staff sign where everyone keeps things confident unless it has potential to violence.
 - Provide the best power-based personal violence prevention
 - Promote positive mental health and suicide prevention
 - Promote positive health behaviors
 - o It has been proven that students resist these harmful behaviors after using these programs.
 - o Budget
 - There is a student fee that pays for the Wellness Center (Health and Wellness Fee). \$9 of that fee goes to the Wellness Center.
 - Total salaries are \$260,768. Wellness budget pays \$177,424.
 - The 2011 Admin Fee wipes out about \$50,000 in reserves.
 - A fee increase of \$2 (Fall/Winter/Spring) would be required to prevent the Wellness Center from going into a deficit next year.
 - Mike So it's \$2 per quarter? Is it open during the summer?
 - Richard Yes, \$2 per quarter and it is open during the summer.
 - James Why haven't you considered administering this fee to summer students since you are open in summer?

- Richard We aren't as busy during the summer and most of the students coming in are for incoming students so they will be paying it in the fall.
- James Maybe we should add more programs in the summer and then request summer students to help pay this fee.
- Richard We have already cut our staff for the summer so to do anything more in the summer will mean an increase in costs.
- KJ I think that \$2 is very minimal considering that student health is so important.
- Richard Looking at ways to save money but we pay all of our student minimum wages. Have cut back on travel unless we get grants. Numbers of mental health cases have increased across campus. All of our staff is extremely well trained.
- Mike Sample size for the surveys?
- Gail Over a thousand students. About 40% were first year students but it was equal gender response.
- Mike How many hours are spent doing grant writing?
- Gail Particularly students don't participate in grant writing. It would usually get done after hours.
