When looking at financing options for implementation of each solution, CWU plans to use Washington State provided Capital Funds, incentive funds from our local utility provider and university provided operational funds. Our goal is to avoid the planned use of third-party financing solutions. We also need to set goals that allow for the best use of Federal Inflation Reduction Act funding. We are open and willing to the possibility of federal grant funding and look forward to any opportunities presented to us throughout this project.
- 3. Only part 2 of Standard Form 330 needs to be completed and submitted as an appendix. Part 1 can be part of the RFQ deliverable illustrations.

- 5. Within Deliverable 1, bullet #5 states the following, "Identify and provide recommendations to address "highest risk" associated with CWU's utility infrastructure." When determining the highest risk associated with CWU's utility infrastructure, it would be expected that the team reviews essential utility infrastructure for indicators of potential failure needing immediate attention. (i.e. old age, construction type, excessive use, anticipate failure within 2 years)

CWU is to abide by strict selection policies that are regulated by Revised Code of Washington for both consultant and construction firm selection on all projects.
