

### NOTICE OF ENVIRONMENTAL CHECKLIST AND DETERMINATION OF NONSIGNIFICANCE

Notice is hereby given that Central Washington University (CWU) has received a project specific Environmental Checklist regarding the construction of the CWU North Academic Complex.

**Description of Proposal:** CWU is currently planning to develop the North Academic Complex (NAC), which is a new 108,000 square-foot building to be located in the north central area of campus on the south side of Dean Nicholson Blvd, which is the current location of the International Flag Plaza.

The heating and cooling system for the NAC will consist of a new open-loop ground source heat pump system drawing from the Ellensburg Aquifer to be housed in a separate building currently intended to be located on the north side of Dean Nicholson Blvd northeast of the building site.
