On average, 3,800 visits are made to the gallery each year by students, faculty, staff, community members, and out-of-town guests.

Highlights from the 2019-2020 Academic Year

- 1. Exhibits and lectures were presented with a focus on current themes and practices in contemporary art:
- (a) The Poster Show was an invitational exhibition featuring posters by fifteen innovative commercial graphic designers and design educators, whose work is nationally and internationally-known.
- (b) The gallery organized it's fourth INTERSTATE: Where I-90 meets I-82 biennial juried exhibition, the proceeds of which support student scholarships in the CWU Department of Art + Design. The juror for the 2019 INTERSTATE exhibit was Grace Kook-Anderson, Curator of Northwest Art at the Portland Art Museum.
- (c) Visiting artist Natalie Krick exhibited and discussed her recent work that uncovers the role photography plays in constructing illusions of female beauty and sexuality. Krick photographs herself, her mother, and her sister in poses and settings that mimic the glamour of magazines.(d) Baltimore-based artist Elizabeth Crisman gave a lecture and displayed her mixed-media artwork that explores issues related to archaeology and human history. Crisman is the Director of the Montpelier Arts Center in Laurel, Maryland.
- 2. Gallery programs and staff were moved online for the latter portion of Spring 2020:
- (a) The spring 2020 Senior Exhibit was organized completely online and the artwork was displayed on social media. The exhibit featured work by 32 graduating seniors in the areas of

studio art and graphic design. At a Zoom awards ceremony students received \$3175 in awards, including four art purchase awards.

(b) The gallery's student workers "took over" the Department of Art + Design's social media accounts. They posted several times each work, in social media features that highlighted artwork by undergraduate and graduate students, and alumni.

The mission of the Sarah Spurgeon Gallery is to offer the campus of Central Washington University and the community at large the opportunity to view and experience art first hand. Exhibits and programs are designed to support the Department of Art and Design's teaching objectives as well as to enhance, engage, and challenge the viewer's knowledge and understanding of art.
