CentralNewsWatch (CNW) is comprised of approximately two to five student employees. These student employees serve as the leadership staff who lead a team five to ten reporters (who take CNW as an academic credit). The leadership staff goes above and beyond the duties outlined in the academic setting. They work diligently to fulfill duties specific to their leadership position and are ultimately responsible for directing and producing the only video news source for Central Washington University (CWU), Ellensburg and Kittitas County.

A faculty advisor helps the leadership staff develop skills and provides real life experience and job training related to broadcast journalism, leadership, management, community relations, reporting and serving for a greater good.

The news stories published by the students has a large impact on campus and the community. They see CNW as a reliable and valuable source of timely, newsworthy and intriguing information. Coverage includes CWU events, community interest pieces, breaking news, feature profiles, CWU athletics and much more.

The student leadership staff is also responsible for regularly uploading content on social media which includes live feeds. Student employees are gaining great experience interpreting trends, learning to disseminate information through media outlets relevant to an audience, exploring and implementing new ways in which to keep viewer's engagement and interest.

During the COVID 19 shut down of campus, CNW posted all stories on our <u>YouTube channel</u> and on our <u>Facebook page</u>. When the pandemic shut down the nation, CNW had 2300 Facebook followers. Today we have over 3700 followers on our Facebook and Instagram accounts. That's an indication of how much CNW has grown even with the reporting challenges posed by the pandemic.

COVID 19 forced CNW out of the studio where we had produced a weekly live newscast. The management crew has spent tireless hours Fall quarter working on getting the studio back up and running. We anticipate producing live newscasts again Winter quarter.

CNW received second place honors in the College Media Association Pinnacle Awards for Best TV Special Event Coverage. A story on the Eaton cattle drive through the Ellensburg Canyon produced by Laynie Erickson earned the award.

Cowles Media, with stations in Spokane, Yakima, Tri-Cities and across Montana, hired over a dozen former CNW team members in the last two years. Cowles management refer to their Central hires as "the Central Mafia."
