 - i. OPR will spend this money on contracts for professional training in Wilderness First Responder, Swiftwater Rescue & AIARE Avalanche Level 1 Course. Additional a contract with The Summit at Snoqualmie exists so OPR can offer discounted ski & snowboard lift tickets to this resort.
- c. CWU-Supplies: \$1,678
 - i. OPR will spend this money on credit card fees collected on each credit/debit card transaction at OPR.
- d. CWU-Utilities: \$1,441
 - i. OPR will spend this money on monthly phone bills for OPR to conduct business.
- e. CWU-Cost of Goods Sold: \$0
 - i. OPR will not spend money here.
- f. CWU-Insurance: \$629
 - i. OPR will spend this money on a monthly lease for the OPR copier/printer/scanner.
- g. CWU-Program: \$45,749
 - i. OPR will spend this money on the purchase of new outdoor equipment and upkeep/maintenance/repair of existing equipment.
- h. CWU-Travel: \$691 OPR will spend this money
 - OPR will spend this money on CWU Motor Pool vehicle rentals for summer programming.

 - i. OPR will spend this money on replacing 10 whitewater rafts and replacing our worn out Nordic skis, boots, poles & bindings.
