1. In what ways does your program support CWU students? Please be specific, yet concise.

ASCWU Board of Directors consists of six elected student officers work to represent all CWU students equally and fairly and to ensure that their voices are heard. From facilities to academics, the ASCWU Student Government helps advocate for student concerns and creates programs to make the Central college experience more memorable. Each office has their own unique specialization representing the student body across the Ellensburg campus and also the University Centers. These budgets help support our mission, student wages, programs, and additional purchases that help ameliorate the student life at CWU. The Director of Governmental Affairs, oversees statewide legislative issues pertaining to higher education and all issues affecting students. The Director and their staff are dedicated to serving the public as the liaison between the ASCWU Student Government, the state legislature, and the Ellensburg city council.

The mission of the ASCWU Board of Directors is to support, represent, and empower all CWU students in their journey within higher education. ASCWU currently leads informal assessments throughout the year and evaluates effectiveness based on engagement with the student body. Each board member works to evaluate effectiveness based on their scope of responsibilities and duties. This programs pertaining to Governmental Affairs, effectiveness of programs are measures by students drive to want to do more than what is done at the event, wants to know more and become more politically engaged.
