ASCWU Board of Directors consists of six elected student officers work to represent all CWU students equally and fairly and to ensure that their voices are heard. From facilities to academics, the ASCWU Student Government helps advocate for student concerns and creates programs to make the Central college experience more memorable. Each office has their own unique specialization representing the student body across the Ellensburg campus and also the University Centers. These budgets help support our mission, student wages, programs, and additional purchases that help ameliorate the student life at CWU. The Director of Student Life and Facilities organizes and participates on Advisory Boards with the SURC departments: the Recreation Center, the Student Union, Dining Services, and the Wildcat Shop. They serve as the liaison to the Residence Hall Association, and sits on or appoints students to sit on various committees around campus such as search committees, or capital projects planning.

The mission of the ASCWU Board of Directors is to support, represent, and empower all CWU students in their journey within higher education. ASCWU currently leads informal assessments throughout the year and evaluates effectiveness based on engagement with the student body. Each board member works to evaluate effectiveness based on their scope of responsibilities and duties. The ASCWU Director of Student Life and Facilities also chairs SURC Governance boards that explore topics such as utilization of services and challenges university departments to evaluate their effectiveness of services to students.
