They feel they need to honor that agreement. Maybe suggest that they say students with a BDTA have met the business foundation course requirements and not put in the exception. Michael will set up a meeting with Business and Registrar's office to discuss the concerns and see if we can come up with language that works for the department and registrar's office.

College of Arts and Humanities is planning to put forward a Liberal Studies major proposal. 15 credits for large major, 45 electives and the list is over 500 courses in the electives.
