Meeting was called to order at 3:20 p.m.

\#36 MATH 299S Learner outcome \#2 doesn't sound like an outcome.

Chair updates - Michael reported there has been a request to shut down Curriculog for a period of time over the summer. Gail Mackin is wanting to change the process to integrate more directly into PeopleSoft. Michael has asked her to come and present her requests at the next meeting. They would also like to suspend the 15 day deadline at the college level, so they can create college level curriculum committees. Michael reported Faculty Senate will be creating a workgroup independent of this committee to evaluate the entire curriculum process and to start making recommendations. Rose sent an email regarding the approved course changes this late is creating a significant issue for the Registrar office.

Registrar - Mike Gimlin indicated if the committee wants to have CurricuLog forms changed, he will need that information.

Teri asked if the Distinguished Faculty Fellows as a university designation for service learning courses could be put on the agenda for next week.
