\#41 GEOG 311 -Outcome \#6 says "research is aware". Not sure if research can be aware. Maria will do a form.
\#18 EDSE 410 - Course outcomes use recall and describe. Low level outcomes for a 400 level course. This is okay
\#44 GEOL 320 - Looks like there is a typo.
\#47 GEOL 370 - The second and fifth outcome are multiple outcomes listed together. Maria will fill out a form.
\#26 ENG 510 - Needs clarification on the description of changes. Learner outcomes don't match in the two boxes. The display outcomes will be fixed. The full learner outcomes are the ones that need to be reviewed.
\#49 GEOL 384 - Typo, there is not a space between ocean and atmosphere.
\#93 PUBH 525 - Description is 42 words. Ben will fill out a form.
\#94 PUBH 571 - Typo in their second to last outcome. Grammatically misspelled audiences.

\#53 Geology Major, BA - Narrative says at the end of first paragraph "This major is the most efficient pathway to receive teaching endorsement in Mathematics". Mathematics isn't mentioned anywhere else in the proposal. Michael will email them for clarification.

Classes are now $100 \%$ online next quarter. There are a few departments that are evaluating how they are going to do lecture and lab courses. For some departments, the labs are separate and for some they are linked together. Some may be creating two new courses and offer the lecture in spring and the lab next fall. It could be possible to do special topics. Education is being hit hard with student teaching. Keep an eye on email. There are procedures for emergency approvals outside the normal process.
