Meeting called to order at 3:12 p.m.

Michael moved to approve the minutes February 24, 2020 with amendment to note petition 2-24.20.06 was recommended to approve and amend Maura's motion that it is clear VNKN 12 was part of approval. Cynthia seconded and motion was approved.

Assessment planning – It was asked if this document would lock the committee into this rotation? Whom does this go to? Michael moved to approve the Teri's GE assessment timeline by year as a plan for the GE plan assessment. Cynthia moved and motion was approved with one abstention. Cynthia asked to work with Teri to make the document more readable. There are no indents and colors are difficult. Send to the Executive Committee to get their feedback.

Student Petitions

3-1-20.1 AIS 101 or 102 - AIS 102 for K2, P3, P6 recommend to approve, no rule

3-1-20.2 COLL 102 - Recommend to deny

3-1-20.3 CWU waiver - Recommend to deny. Student did not meet the minimum to have the course waived and UNIV 101 does not meet that requirement.

3-1-20.4 FCL 419 - Recommend to approve

3-1-20.5A - Fixed with articulation

3-1-20.5B - GEOG% 100 comes in as K4, P3 but they want it as K8. Recommend to deny, because it will come in at K4. The committee would need a syllabus to move into a different area.

3-1-20.6 CIS 114 - Recommend to approve, no rule

3-1-20.7 IDS 316 – Course looks better as a K5, but does not really look like at K4. Recommend to deny, but could be used for K5, P6, no rule.

Cynthia moved to approve 3-1-20.1 AIS 102 K2: Community, Culture & Citizenship, P3, P6, no rule; deny 3-1-20.2 COLL, deny 3-1-20.3 CWU waiver; approve 3-1-20.4 FCL 419 with no rule, deny 3-1-20.5B for K8: Science & Technology; approve 3-1-20.6 CIS 114 for QR, no rule, deny 3-1-20.7 for K4: Global Dynamics, but could be used for K5: Humanities, P6 with no rule. Michael seconded and motion was approved

CE courses that are being petitioned – The committee asked for a list of the student petitions they have reviewed this year.

Cynthia moved to allow the Registrar Office permission to approve any student petitions for any Culminating Experience courses that have been approved by the committee for fall 20-21 without needing to come to the committee for review. Michael seconded and motion was approved.

Michael moved that student petitions for a CWU CE course that is not currently a CE course or not approved for the 20-21 academic year be brought to the GE committee for consideration. Cynthia seconded and motion was approved. One abstention.

Michael asked that the Registrar Office hold off on these two motions for another week to allow the Faculty Senate to approve the General Education program change.

184-subtopic part of major - The committee talked about the request to allow 184 into the major. There are issues with the departments being allowed to make it part of their program. It was suggested to make it part of policy or rules to not allow the 184 subtopic as part of the major. Teri moved that the GE explore policy options or rule options to find the best fit to exclude 184 from programs. Cynthia seconded. Approved.

Transfer articulation courses - Move this to next week.
