184 First Year – We have about 35 students who have taken or are taking 2 to 3 184 courses. These students have received a communication about this. Becky reported they are trying to ensure that this doesn't happen again. Registrar office is trying on the backend to try and stop students from being able to take multiple sections. An option was given to students to use these additional sections a one-time exception to use their second FYE as general elective credits that will count towards their 180 graduation requirements and cannot get additional GE credit. This will only happen for two sections, for those who are enrolled in a third section, if they didn't drop the course, are being allowed to take one of the 6 week courses available this quarter. These are under Continuing Education. The CE courses were

offered for Running Start students and for those students who needed to drop a regular course and could pick up another. The decision on the courses was a discussion with Edez and the deans. Gail indicated that PeopleSoft is not set up for variable prefixes and to set them up as repeatable or not. Mike indicated it is less complex than you would think. Originally they were not put in an equivalent course group. Starting this spring they were put in an equivalent course group so it will catch repeat for any prefix. Students will get a message they are repeating a course. Hope to have this a hard stop in the future.

Becky discussed whether programs can include 184 as part of the major/minor. Curriculum committee will talk about this Thursday. They are going to discuss that the verbiage should be a department cannot require a student to take a specific 184. Curriculum committee might suggest may not require versus must not take a 184 as part of a program. Transfer students are currently not allowed to take 184

Teri moved to approve Concordia courses HUM 152, SCI 110, HUM 351 and REL 371. Cynthia seconded and motion was approved.

Teri moved to deny Concordia courses LDR 198, REL 211, REL 221, REL 401, ENG 202, and HUM 288. Cynthia seconded and motion was approved.

Becky and Gail are meeting with the data folks on Wednesday. They have a list of data needs from colleges, Becky and Gail. Mostly captures these are things we know that individuals need to know from GE data. Becky would like to help the committee take ownership we really want to strengthen these areas and research areas that need data around.
