- 1. Zoom meeting came to order at 3:03 p.m. with quorum.
- 2. Minutes motioned to approve by Eric Foch, seconded by Andy Piacsek, approved.
- 3. Chair updates:
 - a. The Faculty Senate Evaluation and Assessment committee talked about students who were removed from a course for plagiarism, that student should not be able to fill out the SEOIs. More updates on this in the future.
- 4. AAC20-21.13 Final look at 5-90-080, Disruptive Behavior in academic settings:
 - a. Andy made minor changes to the document; each were looked at, discussed, and resolved.
 - b. Wendy discussed her reason why this policy is being addressed. Students need to treat faculty with respect, some female faculty get mistreated by male students at times.
 - c. Andy motioned as amended, Eric seconded, approved.
 - d. Gail recommended this go to the AG after David runs it by the EC/Provost Council before going to Faculty Senate.
- 5. New Business:

AAC20-21.14 -

a. Discussion on WAC 106-125 about adding statements to CWU policy or how to use WAC in our policy. What is the procedure, approval for faculty to reach up to conduct officer; how, when and procedure to use WAC.

- b. What is the process once faculty finds plagiarism; once plagiarism is established what is the procedure; who is notified chair, AD, student rights & responsibility officer? Then move to information from WAC and follow procedure.
- c. Same with repetitive violations of disruption in the class setting. This process should be in policy and catalog.
- d. Academic offenses may have different disciplines depending on cheating or plagiarism.
- e. Steps faculty suspects cheating may have occurred, determines offense or teachable moment, faculty and student discuss, and syllabus will be followed failure of paper or class?
