Becky provided an overview of what happened at the open Executive Committee meeting and concerns about how she was treated.

Committee charges timeline – The committee talked about GEC 20-21.03 charge. This didn't get much traction last year. Teri moved to begin the integration process to change First Year Experience in reference to the 184 course to PadStone as recommended by GECM. Cynthia seconded and motion approved.

Culminating Experience (CE) courses – The committee discussed some issues with MyCWU and some of the CE courses. Becky will talk to the departments regarding the fact MyCWU has some issues multiple courses meeting this requirement and will ask we can use the last course in the sequence instead of all of the courses within MYCWU. All of the courses are needed for GE to meet the outcomes, but they have pre-regs that would make the last the most feasible to put in MyCWU.

RFP proposal – The draft proposal is not quite ready yet around assessment this year. Bernadette is not sure if the funding they thought will be available.
