Bylaws and Faculty Code Committee April 4th, 2022

1. Meeting called to order at 3:33pm

2. BFCC March 14[,] 2022 minutes approved. Nathan White moved the motion to approve minutes, Mark Samples second, all approved without changes.

2. Chair updates

- Update on potential members for 22-23 BFCC: Dan Lipori no (next year too hectic with CBA and other departmental responsibilities. Chris Schedler also declined.
- Mary reviewed that EC took Charge .04 (Emeritus privileges) off of table for this year. Mark said that EC wants to leave Faculty Code language as is.

3. EC updates:

- Mark reported that definition of "department" (to come from the Provost) for charge .02 will need to be revisited next year.
- CWUP language for Charge .01: Greg will talk to the President at next meeting, EC hopes to have this go through this year, in order to protect the Faculty Code. BFCC agreed that if President wants language to go into a different area of CWUP (other than the proposed "Shared Governance" section), we are okay with this. The most important thing is that it gets into CWUP, at this point it doesn't matter where.
- Mark reviewed the three motions that will appear on Senate agenda this week; Two motions for Gen. Ed, and new schedule of assessments from EAC.

- Mark will complete his review of Bylaws and BFCC will continue editing next meeting.

- 2. Responsibilities of the committee:
- 2.1. The committee receives its charges from the Executive Committee.
- 2.2. When requested by the Executive Committee, the committee reports to the Faculty Senate and/or to the Executive Committee.

Nathan pointed out that BFCC does more than receive charges and report to EC. Charges must be completed/addressed, etc. Language needs to be revised.

Proposed charges for next year (2022-2023) to be included on year-end-report:

- Clarification of EAC duties in Code
- Review Code and Bylaws for gendered language.
- Review Code and Bylaws for wording issues discovered when reviewing code this year for inconsistent committee titles.
