22-23 Curriculum forms – Mike G indicated that the Course Change form has an additional field in the for General Education courses if they are changing their learner outcomes to make sure they are realigned with General Education outcomes. Most of the rest of the forms are just cleaning up of language and format. Graduate approval steps are left as they were last year. Jeff will collaborate with Graduate Council this summer or next fall to try and make sure what needs to be done for this. Sayantani indicated that the word "professional" in type of course section is misspelled.

The committee approved the Curriculog forms.
