#30 CMGT 440 – The second learner outcome as written seems like there are two learner outcomes in one box. This could be split into separate outcomes. The activity only seems to reference one of the outcomes. Ben will do form.

#36 CMGT 452 & #38 CMGT 456 - There are a couple of typos that Ben will send to Trista.

#38 CMGT 456 - Has typo, but selected that it was in GE. It doesn't appear to be in the GE program. If it isn't in the GE program, it will be moved forward. This is okay.

#31 CMGT 441 – Learner outcomes #2 in terms of assessment. #4 also indicates a specific requirement. Should this be more general.

#34 CMGT 447- Adding the word Laboratory to their title. They list this course as a lecture/practice course. Another course is also adding the word Laboratory they have it listed as lecture/lab. Should this course be lecture/lab?

#58 IHP 350LAB – Can you increase credit hours just based on students need to spend more time out of class. The lab time is not increasing, but it is because students are spending more time outside of class. This increases the workload for faculty in the course and is this appropriate? Kurt asked that it be held at the committee level while he works with the department.

#8 ASL 401 – Changing from 301 to 401. This is layered with 501. Some concerns about the learner outcomes and assessments. Lizzie will do form.

#40 CMGT 461 – Specific lesson outcome #5. CWU Science II building, but this is now Discovery Hall. Tim will do a form. #4 specifically identifies a company in the activity. Tim will do form.
