Course Name: ADMG 184 FYESTS Idea Machines: Sparking Innovation, Entrepreneurism, and Leadership

Credits: 4 | Prerequisites: NONE

COURSE DESCRIPTION:

Special topics selected by faculty introduce scholarly approaches to problem solving and methods of inquiry. These small classes emphasize mentorship and incorporate, writing, critical thinking, oral communication, and information literacy.

This first year experience will have students examine and learn the techniques and technologies to foster innovation and entrepreneurism. Develop a creative and technological problem-solving skill set applicable to everything from academic projects, to entrepreneurial development, to innovative solution building for the increasingly complex problems facing society as a whole.
