Course Name: ADMG 410 Comparative Global Studies in ITAM I

Credits: 4 | Prerequisites: Acceptance into study abroad program

COURSE DESCRIPTION:

This course offers the student an opportunity to study and experience various industries operating in another country or region with an emphasis on global information technology, retail management, entrepreneurship, and leadership. Acceptance to study abroad trip. Grade will either be S or U. Permission of department.

COURSE OBECTIVES

Students will be able to use	Assessments
Using theories of leadership, compare and contrast leadership and management styles between the U.S. and the foreign countries. In particular, hypothesize WHY you think the U.S. and foreign countries have developed their particular style of leadership and management.	Comparative paper on leadership and management differences between the U.S. and the foreign countries. Graded with a rubric.
Identify at least 5 differences between B2C in the U.S. and B2C in the foreign country.	Written journal entry and/or discussion board post.
Identify at least 2 forms of IT used in the foreign country that have not been widely adopted in the U.S. You can also identify at least 2 forms of IT used in the U.S. that have not been widely adopted in the foreign country.	Written journal entry and/or discussion board post.
Identify at least 5 differences between B2B and B2C communications in the U.S. and B2B and B2C communications in the foreign country.	Written journal entry and/or discussion board post.
Extrapolate from your understanding of the history of the foreign country how that history has affected both business and non-business relationships.	Written journal entry and/or discussion board post.
