Course Name: ADMG 412 Comparative Global Studies in ITAM II

Credits: 4 | Prerequisites: Acceptance into Study Abroad Program

COURSE DESCRIPTION:

This course offers the student an opportunity to study and experience cultural differences and similarities in another country or region from the perspective of IT and administrative management. Acceptance to study abroad trip. Grade will either be S or U. Permission by department.

COURSE OBECTIVES

Students will be able to use	Assessments
Using the LESCANT model, analyze culture and communication patterns of a foreign country.	Group assignment with class presentation/role play.
Summarize the cultural differences between the U.S. and the foreign countries. Summarize these differences in both the business environment and the cultural (non-business) environment.	Comparative paper between the U.S. and the foreign countries on cultural (business and non-business) differences. Graded with a rubric.
Based on an understanding of the U.S. and the foreign countries, hypothesize the differences in diversity, particularly gender, age, and disability diversity.	Written journal entry and/or Discussion Board post.
Learn at least 5 common terms in the language of the foreign countries.	Oral presentation
State the differences between the U.S. and foreign countries economic and political systems (current or historical) and how those systems effect business.	Written journal entry and/or Discussion Board post.
