Course Name: ADMG 424 Advanced Administrative Policy

Credits: 4 | Prerequisites: ADMG 371, ADMG 372, ADMG 385, and Senior Standing

COURSE DESCRIPTION:

This course is a "capstone" seminar in policy and strategy for administrative managers. Concepts explored include contemporary issues in strategic administrative management and organizational policy; frameworks for strategic analysis, decision making, implementation and control; strategic intent and the core competence of the organization; analysis of resources and capabilities; strategies and policies for IT integration; and culture and change management.
