

# SYLLABUS

**Course Name: ADMG/IT/RMT 490 Cooperative Education  
(Internship)**

***Credits: 1-12 | Prerequisites: RMT 379 and Learning Agreement***

## **COURSE DESCRIPTION:**

The Information Technology Management (ITAM) Department at CWU requires an internship for all students in the major program. Our goal is to provide students with the opportunity to apply classroom learning and gain first-hand experience. ITAM considers an internship to be a structured and supervised professional experience, within an approved agency, for which a student earns academic credit. It is guided by well-defined learning objectives and supervised by both academic and business personnel.

## **COURSE OBJECTIVES**
