**Course Name: IT 105 Protecting Your Online Identity**

**Credits: 4 | Prerequisites: NONE**

## COURSE DESCRIPTION:

This course will expose students to the potential threats being thrust upon them daily by simply using the internet and how to neutralize or greatly reduce these risks.
