

## **SYLLABUS**

### **Course Name: IT 165 Seeing Through the Data**

Credits: 4 | Prerequisites: Students must achieve an appropriate math placement test score resulting in eligibility for MATH 101 or completion of MATH 100B with a C or higher, or completed another Gen Ed QR course, or have a DTA.

#### **COURSE DESCRIPTION:**

This class examines the influence of big data on social media, the internet and society. Students will acquire data sets, analyze them using basic statistical tools and be able to present data-driven, validated results.

#### **COURSE OBECTIVES**

Students will be able to	Assessments
Define big data and analyze its influence on the internet, social media and society.	Graded written assignment

Evaluate the quality and validity of data used to support a claim or argument.	Critical Analysis of Data – Students will be asked to find media or social media examples that use data to make a claim or an argument.
Construct and deliver effective presentations of data-informed conclusions to a specific audience.	Data Reporting Project – students will discover some best practices for preparing and presenting the results of data analysis.
