Course Name: IT 363 Data Mining for IT Managers

Credits: 4 | Prerequisites: IT 359

COURSE DESCRIPTION:

Students will learn to extract data, apply learning methods, and prepare data for further analysis.

COURSE OBECTIVES

Students will be able to	Assessments
Explain the procedures involved in extracting useful data from multiple sources in an IT Management context.	Data Mining Strategy: Assess a data source and determine the best way prepare and utilize the data for analysis in an IT Management context.
Differentiate between intelligence and analytics and describe the role of each in data-driven decision making.	Analysis Paper: Students will apply the model to a real-world IT scenario and explain each step in the analysis process.
Explain various supervised learning methods that can be used to derive meaning from trained data sets in an IT Management context.	Supervised Data Analysis Project: Students are provided with sample data sets and are asked to explain how supervised methods can be applied to each in an IT Management context.
Explain various unsupervised learning methods that can be used to derive meaning from large sets in an IT Management context.	Unsupervised Data Analysis Project: Students are provided with data sets and are asked to explain how unsupervised methods can be applied to each in an IT Management context.
Identify the best tools to apply to data sets to prepare them for analysis in an IT Management context.	Data Preparation Scenario Assignment: Students will be given a data mining scenario and will propose a course of action for processing the data and getting it ready for analysis.
