    - Want to contact the Observer staff about possibly doing a weekly column in their paper for a smaller fee
  - Met with Lola and talked about how to expand BOD awareness and also talked about elections plans

## **Officer Reports:**

- Executive Vice President: Paul Stayback
  - Had S&A meeting last week.
    - They voted on funding requests. The one (12005) that was an urgent request and a motion was made to vote on it that week. S&A voted approve it without BOD input because it was an urgent request.
    - S&A has been showing some financial restraint
  - o Heard back from the auditor, will be talking about that later in this meeting.
- Vice President for Clubs and Organizations: Maylin Sevilla
  - Found out the access to the Facebook page but we're trying to get access to the group page
  - Started typing up the club descriptions
- Vice President for Academic Affairs: Allyson Mundy
  - Steve would like to entertain a motion that Allyson and Mike give their report later in the meeting. Paul makes the motion, James seconds. All in favor, approved
  - o Mediation process/advising/helping student appeal a grade

- Had SAS Executive Board meeting on Thursday
  - We had several funding requests
  - Went through suggestions/recommendations I feel should be implemented to make SAS successful
  - Double our meetings with Executive board to accomplish those goals.
- Met with Jesse Nelson and Carolyn Thurston
- o BOD website- more student centered/user friendly/resource list etc.
- o SAS is scheduled for Nov. 3 (this Thursday) at 8pm in Black 142
- Vice President for Equity and Community Affairs: KJ Stilling
  - o Every week at the ESC we are going to discuss a small portion of the constitution
  - o This week since the ESC constitution has been approved 3 clubs have tuned in packets filled out for membership.
  - Wednesday I met with the City Council Ad Hoc committee. I listened a lot. Looking out for the interest of the student's interests.
- Vice President for Student Life and Facilities: James Rae
  - o Issue on transportation. Hopesource got a grant for a bus that goes from Ellensburg to Yakima for about \$6.
  - There is a large piece from a local artist that would be willing to either loan his art of sell
    it to us but it doesn't really tie into the university in my opinion. Thought that maybe
    another well-known artist could create something that reflects the university.
  - Banner is up over the doorway. People have commented on it and feel like it's like a "Wildcat Den"
  - Working with assistant to figure out some new programming and see who we can team up with on some new programs. Maybe a So You Think You Can Dance with Wellington.
  - Just had a meeting about possibly merging publicity and public affairs office. Nothing new really came out of it. My message would be that if we are ready to talk about specifics then let's do it.
- Vice president for Legislative Affairs: Mike Merz
  - o No report
- President: Steven Ross
  - Met with Pres. Guadino.
    - Talked about letter that I sent
      - Would like to bring out some school pride. He said he would like to do something that sets tradition on campus and in the community.
  - O Have drafted a litter to the governor and have had a few people look at it and help with it. I feel like the draft is pretty good
  - Will most likely be leaving next Friday for funeral so Paul may have to lead the meeting.
  - o James There is a group of students that are pushing to get a Wildcat statue on campus.
  - Paul Would like to request that you can the final letter for the minutes. Will have it out on Monday but would like everyone to read it.

# **Special Guests:** (Jesse Nelson)

- Want to implement the Student transitions and academic resources (STAR) program to help students find the resources they might need
- We have a big constellation of offices that offer services to students. Most of the time students don't know where to go for the help they need.
- Often times the needs are really great, especially for juniors/seniors

- Would like to plan a response to the need. Have a BOD response as well as an admin response to the need.
- There are three layers
  - o Need
  - Capacity
  - o Plan (Admin and BOD)
- Paul I helped create a position last year that handled student advocacy issues. This seems to overlap with that.
- Jack I think the difference in having STAR handle this is that the other position was for
  problems that were chronic, it's there to oversee students who have problems throughout their
  time at school (people with disabilities). STAR would benefit students who have one time needs
  requests.
- STAR will also help the student go through the mental and reflective process to figure out what they need and where they need to go to figure out how to find their answer. This will give students a place to start.
- We're still at the early stages of this but we have the potential for a student to self-refer to
  either the BOD or administration. A lot of people don't know that they can turn to
  administration.
- Do you as the BOD think there is merit to this?
  - o Paul Is this something that would naturally go to STAR if the personnel were different.
  - Jesse Star will help personnel to reference the intensive resources as well as referral.
     So decentralized right now that it's impossible to anticipate the amount of students that will use this
  - KJ Programs like this could or should be funded by a higher level. I believe that there is a need but the need may be smaller (like 200). I think it's important that students continue to receive the same resources.
  - Allyson I have noticed that there have been perpetual issues that have come to the BOD. It's a lot easier to address these issues when there is a program such as STAR that addresses constant issues.
  - o James I think this is really great in terms of awareness. A lot of these duties would fall under a student advocacy officer position that Paul mentioned so I don't see the need. I think that the need I've noticed is that we need a general information desk on campus that knows everything on campus. Maybe this could be incorporated into STAR as well.
  - Jesse Mediation isn't intended to replace policies and procedures. It's more like information mediation where there isn't already a formal position. Therefore, there wouldn't be an overlap.
  - o Paul Would like for the student advocacy position I created last year to be looked at and find out how it may relate to this program.
  - Steve For the sake of time, if you have any additional questions, comments, or concerns could you email Jesse?
  - Jesse From the BOD, do you think that we should continue planning or should we stop the motors?
  - o KJ I think a SEOI type survey should be created so we can evaluate the need.
  - o Allyson I think it should be a place students can go to find information but also be a place students should go to know where to go.
  - Jesse We can find out some ways to collect data.
  - o By a show of hands, the BOD thinks the STAR program should continue moving forward
  - Allyson My office will continue working on this but if the BOD wants to back out, just let me know.

Dear Mr. Stayback:

Thank you for contacting our Office with concerns regarding possible unallowable administrative costs charged to student activity funds. We examined your concerns and would like to share the results with you.

We reviewed the "S&A Fee Fund – Necessary Services Cost Allocation ("Admin fee") Proposal dated June 1, 2011 allocating \$790,832 of administrative fees to the student activity fund. The cost allocation included indirect administrative charges for 15 categories such as expenses for the President, Faculty Senate, Public Relations, Information Technology policies and management, software licensing, public safety and faculty relations. State law (RCW 28B.15.041) says "services and activities fees shall be used...for the express purpose of funding student activities and programs of their particular institution." Administrative costs such as these do not appear to be for the express purpose of funding student activities and programs. We are unware of any other statute allowing the University to allocate indirect costs to the student activity funds. Further, we found some of the allocations may not be equitably distributing the costs.

Unless the University can provide us with specific legal authority allowing the allocation of indirect costs to the student activity funds, we recommend the University re-evaluate the cost allocation proposal and ensure charges to restricted student activity funds are for the express purpose of funding student activities and programs.

- o James first, you're wrong, it can be used however the S&A sees fit.
- o Paul Letter says that S&A doesn't have the legal authority.
- o James I talked to the WA State Attorney General and they said that it's fine

- Paul Would like to send a letter with a copy of James's letter and come up with a solution to replace these funds. Would also like to ask S&A to defund this Winter Quarter.
- Paul The BOD write a letter to George Clark and request that S&A look at it and defund. Ultimately we might have to litigate this
- o Jack Until we get the okay, defund it?
- o Paul Yes
- o Jack So we will just have them follow the third paragraph of the letter.
- o Paul This letter allows us to make it public
- Steve As long as we're tactful about it. We do have facts now but we have to handle it tactfully.
- o Scott Would you share this letter with George and the president before its public?
- o Paul I looked for their availability this week but they aren't available.
- James To be brutally honest, I don't think that it's deserved. Students are going to be paying extra this year and they deserve the right to know about this.
- Allyson I agree with James but we need to be the bigger person and stay tactful throughout this process.
- o Paul –Ask S&A to defund starting winter quarter.
- o Allyson A little weary because S&A may thinking we're micromanaging.
- Paul We aren't requesting, we're asking.
- Sharon Suggest that they understand that you're looking at another raise in fee in they
  don't do anything. They're asking that the admin fee be collected at the same rate over
  the next 5 years.
- o Allyson I think the people on S&A need to understand the severity of the situation.
- Paul I move that I send that email out to George and that letter and previous letters to S&A and request that they approve it. Ally seconds. All in favor, approved.
- o Paul there's a very real possibility that we need to ask S&A if they would pay for litigation. I think we need to consider if we are willing to do it.
- Allyson I think that if we take a stance then we need to take a firm stance so that we don't get trampled on in the future.
- Sharon This has far reaching impacts across the state and other universities.
- o Jack It could be class action.
- Steve I'll reach out to other university BODs
- o Jack We're probably the only campus that has an admin fee all 4 years. Most universities have only 2-3 year admin fees.
- Scott Would be willing to bring this up at my meeting next week
- Sharon I like that how now that you have this problem, you're trying to find solutions. I
  think it's great that you're being tenacious about it but you're also looking at
  alternatives and solutions to the problem.

#### Club equipment purchases

- Everything that the clubs buy is university property. How do we want to approach this in the future? Maybe we not allow funding from SAS and Club Senate so we can avoid the problem of inventory. If someone takes the supplies, its university owned and therefore state property. Its theft if people keep it.
- Sharon Its intended that SAS don't fund departments and to make sure that they only fund club needs.
- o Paul Consumables aren't state property but if for example you buy a hammer, that's state property. I recommend that we don't fund durable goods. Does the BOD have the authority to say that we don't recommend this?

- o Allyson I think that some sort of policy and procedures be created.
- o KJ We should make a criteria that if students don't meet a criteria then they don't get the funding.
- Sharon say the biology club buys a telescope but they keep it in the biology building, that's close to us funding the department. It's a sticky issue.
- Paul Move that we go into exec session because Heidi (minutes taker) has to leave,
   KJ seconds. All in favor, mike abstains.
