Mike Not going on the ballot, we'll just change it.

Understand there hasn't been an increase in years but considering this year's events it should be put off until next year. Ally- Minimum wage has gone up considerably. Think we should increase the pay. Mike Like the idea of a retention incentive after the first quarter as something we can take away. Steve we can cut an officer's pay. May seem hypocritical to have a retention incentive. Paul something that can be decided next year's BOD. James The retention incentive idea is thoughtful but would sound hypocritical. Agree with Ally that our pay hasn't been increased but neither has a lot of other people on campus. Don't think it's fair to ask for a raise. Straw poll who wants an increase (no)
  - Term of office maximum two years. Change language to say (less than three years.) Ally change to quarters. Paul think it says that a
