IV. Halloween Expenses

- a. Catering expenses is estimated to cost \$439 with the estimate for attendees being about 30 based on previous trends.
- b. The event will take place in in the ASCWU office Friday October 27th from 5:00 PM to 7:00 PM.
- c. FASA ESC Rep asked if the event is open to all? President Cantu clarified that it is open to all.
- d. Speaker Johnson recommended to strive for a bigger attendee count.

- e. **Director Granados-Montes De Oca** recommends to start promoting the event as soon as possible to ensure the best possible attendee turn out.
- f. **Director Carrillo** asked for the head count from the open house, but **Director Granados-Montes De Oca** clarified that the attendees from the open house needed to go to show up in order to gain points. Therefore, it would not be accurate data to use as a reference.
- g. **Senator Hondo** suggested to match the marketing efforts, so they reflect the overall budget amount to increase the attendance rate.
- h. **Director Granados-Montes De Oca** pointed out that the most engagement students had last year was during RACK week because there were people tabling downstairs and would lead students to go upstairs to the office.
- i. Senator Estaquio pointed out that the purpose of this event is to have students engage with the BOD and the office as a whole but 3 directors will not be present for the event.
- j. **President Cantu** recommends changing the date and marketing budget to have a better outcome.
- k. **Senator Hondo** suggests changing the day of the event from October 27th to October 28th because Boo Central will be happening the same day and could increase the number of attendees.
- 1. **Director Granados-Montes De Oca** responds by mentioning that Boo Central is on a Saturday and it is unknown if staff will be able or willing to work on the weekend. **President Cantu** adds that in this case, changing the day will not address the current predicament that 3 directors will not be present. **Senator Estaquio** further pointed out that Boo Central is a student only event and the office haunting event is open to all.
- m. **Speaker Johnson** asked if any promoting has been started? **Lola**, from publicity, mentioned that the event is already in the Hype book for October 27th and the design is already in progress.
- n. **Speaker Johnson** agrees that the budget is a little high for such little turn out but also recognizes that students depend heavily on the Hype book when it comes to attending events. Along with recommending to minimizing the amount of candy and hot chocolate would help to reduce the cost.
- o. **President Cantu** agrees that it is unfortunate that 3 directors will not be able to attend the event, but it is also a great opportunity for the attendees to meet the senators and ESC representatives.
- p. FASA ESC Rep asked if there will be other opportunities to meet the whole Board of Directors and **President Cantu** clarifies that there will be in the future. The whole board will be present for the Meet the Board Brunch and two other events.
- q. Senator Worral mentions that lowering the candy price and finding an alternative could be a good idea. Along with keeping the date of the event

as it is said in the Hype book would be best. They also suggested tabling before the event to increase engagement.

- r. **Director Granados-Montes De Oca** agrees that keeping the date the same is a good choice regardless if 3 directors will be absent. Along with recommending having more opportunities to meet the senators in the future.
- s. **Director Castillo** suggests to not have the cider beverage or the 2lb. candy bag and lower the number of popcorn balls from 30 to 20 to reduce the overall cost.
- t. **Director Granados-Montes De Oca** suggests leaving catering as is, get rid of the 2lb. candy bag, and lower the price for decorations or barrow previous decorations that are within the office.
- u. **Speaker Johnson** suggests increasing the expected attendance by 10, get rid of the candy bags, increase the popcorn balls to 40 and decrease the gallons of cider to 2.
- v. **President Cantu** points out that catering based the cost for catering on the number of attendees that are expected. **Senator Worrall** adds that, since they work in dining, the price of catering may not change if there is an increase or decrease in the guest count.
