	I understand that the TEACH Grant/Loan is intended for students who plan to become teacher in a High-Need Field and who plan to teach in Low-Income Schools as determined by the U.S. Department of Education, which may be subject to change .
	I understand that I am expected to teach full time for four years within the first eight years following graduation in a High-Need Field at a Low-Income School as a Highly Qualified Teacher.
	I understand that if I am not able to meet ALL conditions in the Agreement to Serve and Promise to Pay, the TEACH Grant will permanently convert to a Federal Direct Unsubsidized Loan with interest retroactive from the date of disbursement .
	I understand that the Department of Education will contact me during and after completion of my degree program, and that I am to respond directly to the Dept of Ed for ALL requests for information and/or documentation. I understand that if I fail to provide the Dept of Ed with information as requested, the TEACH Grant will permanently convert to an Unsubsidized Loan.
	I understand that if I have already been awarded aid up to my Cost of Attendance, receiving the TEACH Grant/Loan will result in the reduction and/or cancellation of my PLUS, Federal Unsubsidized Loan, and/or Alternative Loan .
