From utilizing confidential resources to reporting to the University or law enforcement, **you have choices about where to seek assistance, as well as what, where, and when to report, if you choose to do so.**

- The resources listed in this brochure are divided into categories based on whether they are confidential or private
- Each CWU campus will have varied local resources depending on the location

Anyone seeking assistance, whether for themselves or someone they are concerned about, is strongly encouraged to contact a confidential resource first.

Confidential resources can be a good starting point for individuals seeking information or support because they can outline the various reporting options and resources available, without the responsibility to report the incident to the Title IX Coordinator or law enforcement.

What is Sexual Misconduct?

At CWU, all forms of sex-based discrimination and harassment, including sexual misconduct, are prohibited.

Sex-based discrimination includes discrimination on the basis of sex stereotypes, sex characteristics, pregnancy or related conditions, sexual orientation, and gender identity/ expression.

Sexual misconduct is a broad term that includes acts of:

- Sexual violence/assault
- Sexual harassment
- Sexual exploitation
- Dating/Domestic violence
- Stalking
