As colleges and universities prepare for fully online or blended virtual and in-person learning environments, it is important to understand some basic cybersecurity steps students, faculty and staff can take to make sure they move to the top of the class securely.

#### **Best Practices**

## THINK BEFORE YOU CLICK

Remember what you learned about not accepting candy from strangers? Apply that to the online world as well. Do not click links in emails, text messages, chat boxes, etc. from people you do not know--and be suspicious of links sent from those you know as well.

If you encounter suspicious messages or attachments, please forward them to <u>CWU</u> <u>Service Desk</u> for further investigation. There has been a surge in malicious online activity as cybercriminals and cyberattacks leverage the heightened fear of the public during the coronavirus pandemic.

## PROTECT YOUR PERSONAL INFORMATION

Personal information is any information that can be used to identify you or your accounts. Examples include your name, address, phone number, usernames and passwords, pictures, birthday, and social security number. Do not post or share this information with others.



# What are some examples of Internal Controls?

Examples of common internal controls include:

- **Policies and procedures** (at the department, division, and unit level) that are communicated and that establish what should be done, how, and by whom.
- **Approvals and authorizations** that include a thorough review of supporting information to verify the propriety and validity of transactions.

# What is Internal Audit?

The best way to provide a description of Internal Audit is to start with the Institute of Internal Auditors (IIA) definition of Internal Auditing:

"Internal auditing is an independent, objective assurance and consulting activity designed to add value and improve an organization's operations. It helps an organization accomplish its objectives by bringing a systematic, disciplined approach to evaluate and improve the effectiveness of risk management, control, and governance processes."

Internal Audit can also assist you even when you are not being audited. We act as an inhouse consultant on internal control matters, and we can assist you with information and suggestions on controls in specific areas.

Internal Audit helps the University accomplish its objectives. One of the primary goals of the internal audit function is to make the University better; to add value. Further on in the definition this is reiterated in that Internal Audit is charged to not only evaluate, but to improve the effectiveness within areas that are reviewed.

We can help you...

- Add value to and improve organizational operations
- Establish effective controls, processes, and procedures
- Reduce costs and enhance efficiencies and effectiveness
- Avoid unnecessary risks

How you can help ....

- Notify us if a control is not working
- Share your ideas for improvement
- Do not be afraid to ask for help or advice

# FREQUENTLY ASKED QUESTIONS

**Q:** When should I make an online report to the Internal Audit Hotline?

**A:** Some examples of situations that you may want to report to the Hotline:

- Conflict of Interest
- Fraud/Theft
- Financial Policy Violations

**Q:** What happens when I make a Hotline report?

A: We review all hotline submissions and assess each one before deciding how to proceed. Once received, your report will be handled discretely and treated confidentially to the extent possible under applicable laws. **Q:** Do I have to give my name when I make a report to the Hotline?


**A:** No, you can remain anonymous.

**Q:** What about retaliation for making the report?

**A:** University policy prohibits retaliation against employees who in good faith report apparent violations.

**Q:** How do I start a hotline report?

A: Report a concern using the <u>hotline web form</u>.
