RESIDENT TUITION FOR VETERANS & ELIGIBLE INDIVIDUALS

VETERAN

ELIGIBILITY: You are eligible to pay resident tuition and fees if you are a student who:

- a) Separated from the uniformed services* with any period of honorable service after at least ninety (90) days of active duty service**.
- b) Lives in Washington and enters a Washington higher education institution within three (3) years of discharge from a period of active duty service. The three-year rule does not apply to VR&E applicants.
- c) Has received a Certificate of Eligibility or VR&E authorization verifying VA educational benefit.

CONDITIONS: You will be classified to receive in-state tuition; however, you will not be eligible to receive financial aid benefits that are only available for students who satisfy the statutory requirements regarding Washington State residency for tuition purposes.

PROCEDURES: Complete the application section and attach a copy of your DD-214 and Certificate of Eligibility.

VETERAN SPOUSE/CHILD

ELIGIBILITY: You are eligible to pay resident tuition and fees if you are the spouse or child of an individual who:

- a) Separated from the uniformed services* with any period of honorable service after at least ninety (90) days of active duty service**.
- b) Lives in Washington and enters a Washington higher education institution within three (3) years of discharge from a period of active duty service.
- c) Has received a Certificate of Eligibility verifying VA educational benefit.

CONDITIONS: You will be classified to receive in-state tuition; however, you will not be eligible to receive financial aid benefits that are only available for students who satisfy the statutory requirements regarding Washington State residency for tuition purposes.

PROCEDURES: Complete the application section and attach a copy of your sponsor's DD-214, and Certificate of Eligibility.

DEADLINE: Requests for the change in tuition status must be submitted by the 30th day after the first day of the quarter for which this request is made.

***UNIFORMED SERVICE** include: Army, Navy, Marine Corps, Air Force, Coast Guard, US Public Health Service Commissioned Corps, and the National Oceanic and Atmospheric Administration Commissioned Officer Corps.

****ACTIVE DUTY SERVICE** means full-time duty, other than active duty training, as a member of the uniformed service of the United States.
