- In Radio Programming: Traffic Scheduling, Programming and Scheduling, Production, On-Air Performance, Broadcast Journalism, Sports Broadcasting, FCC Laws and Music Rights, Sports Play-by-Play, Technical Board Operation, and Live performance Mixing
- In Video Production: Live video Technical Directing, Equipment Maintenance, Video Editing, and Content Planning and Production

KCWU also offered Events Support at over 210 events last year, including Bite of the Burg, CWU Football Tailgate, Wildcat Welcome Weekend, multiple events for CLCE, Wellness Center, the College of Business, ROTC, Wildcat Shop, and CWU Recreation.
