1. In what ways does your program support CWU students? Please be specific, yet concise.

ASCWU Board of Directors consists of six elected student officers work to represent all CWU students equally and fairly and to ensure that their voices are heard. The Director of Student Life and Facilities organizes and participates on Advisory Boards with the SURC departments: the Recreation Center, the Student Union, Dining Services, and the Wildcat Shop. They serve as the liaison to the Residence Hall Association, and sits on or appoints students to sit on various committees around campus such as search committees, or capital projects planning. This position and office directly support CWU students with their work on creating and instilling CWU traditions through their oversight of Wellington the Wildcat and support of the Tradition's Keeper program. This office creates a variety of dynamic collaborations such as Wellington's Wildfire, Homecoming support, WildFest, and many other university-wide collaborations.

2. What are your specific program goals or learning/operational objectives? How are you assessing the effectiveness of your program in achieving those targets?

The ASCWU Office of Student Life & Facilities is also tasked with promoting and advocating for CWU spirit on-campus and within the community. The goal of this office is to be active partners with campus partner serving as a direct liaison and voting member on a variety of committees (ex. Wildcat Shop Advisory Board, Student Technology Fee Council, Student Union Advisory Board, SURC Governance, and many others). This office has direct selection, training, and supervision of CWU's Mascot, Wellington.

The effectiveness is evaluated on student engagement with committees, outcomes of SURC Governance, and ability for student leaders to facilitate programs with CWU departments. Beyond informal evaluation, there is no current formal evaluation of programs and events within this office.

3. What is the overall purpose of your program and what service(s) does your program provide?
 - a. Are there overlaps or intersections with other university programs who have a similar purpose or service?

The ASCWU Board of Directors represent student issues to the university administration, work to create positive and inclusive student environments, and offer insight as elected officials on university policies, programs, and initiatives. There are a number of collaborators necessary to ensure that the ASCWU Student Life & Facilities is successful. This position is a primary collaborator and liaison between campus executives (ex. Vice President of Operations, Director of Recreation, Director of Student Union, Capital Planning, Dining Services, Campus Police,

Chief Information Officer, etc.). This office addresses student concerns regarding on-campus student services and facilities.

4. How does your program align with the purpose of S&A funding? *“Supporting co-curricular and extracurricular activities and programs participated in by students in the furtherance of their education.”*

We strongly believe that our mission and governance is very much engaged and within the Killians outline of supporting Student Government students serving students. Student Government is a category mentioned in the Killian Outline as allowable funding. Student Government seeks to empower students to throughout campus in both individual developmental positions within Student Government but also through services and activities to the student body.

Student Life & Facilities directly connects to the university’s mission and goals to create a sense of community and belonging on campus. This office directly elevates the student voice, and engages students in experiences to build connections to “what it means to be a wildcat.”

CWU prioritizes student development across campus to help ensure each student’s experience prepares them for their individual future. ASCWU serves as stewards of the institution representing the student voice across the state, on university committees, the President’s Strategic Plan Committee, and more.

All students at CWU are served through this position but currently demographic data is not tracked beyond the SURC governance utilization committee.
