  - Administrative Assistant-10 hours/week
  - Treasurer-14hours/week
  - Senate approved hourly wage of \$8.20
  - Resource Center
  - All clubs that are recognized can ask for money
  - Clubs that are religiously or politically affiliated are limited on what they can ask for
  - Most requests are academic
  - Sports clubs go to Senate and Bob Ford
    - So expensive, rarely get more that 20% of total cost of event
