- 2. Diversity Education Center- Leslie Webb
 - o Requesting for \$16,667
 - Last year the committee funded the Diversity Center only through Fall quarter to allow the S&A committee time to make decisions on funding for the rest of the academic year 2006-2007
 - Back to request the remainder of the money not allocated last year which is for the rest of the money for Winter and Spring quarters
 - o Money used for programming and retain current staff

 - o Requesting for \$23,000

 - o Will cover musical performance, food, advertising, prizes given out

 - o Plan to do fundraising and plan to raise \$3,000
 - Willing to give back the money that is left over from the event
