Supplemental or Base Funding Requests - Presentations:

Theater Department-Scott Robinson is requesting \$77,350.00 in supplemental funds for 25 students to travel to the Varna International Festival and Performance Tour of Italy June 11-July 7, 2011. The students are committed and will be providing individual support in addition to fund raising, which they have been conducting since the first of the year. The price per student is \$4,830.00 program costs, which covers their expenses for the tour. This is the first time a musical theater program has been invited from west of the Mississippi River and there are only 4 other universities invited to participate. Of the 40 musical theater students in the program, 25 have been chosen by audition before CWU faculty and selected based on their preparation. In addition a festival representative auditioned these 25 students and several have been cast with parts--an unexpected bonus, other students will be singing in the production's chorus. This will also be a cultural exchange (nationally and internationally) and provide priceless opportunities for our students, CWU and the new musical theater program. These students have been contributing to S&A while at CWU and this is a chance to benefit from their contributions-these students generally are in rehearsal and unable to participate in events sponsored by S&A providers. Scott Robinson likened this proposal to a biology student presenting at a conference and the value and professional connections the opportunity brings to the student and CWU.

The Theater Arts Department would also like to propose an additional \$30,000 in base funding for the remainder of the quadrennial budget cycle so the department can plan ahead for opportunities like the Varna International Festival.

Scott Robinson asked if the Varna International Festival travel could be considered tonight, but after a short discussion, it was decided that these proposals will be voted on at the next meeting.
