Update Report:

Supplemental or Base Funding Requests - Presentations:

Physical Education and School Health majors) PESH Guam Teaching Trip – Stefan Ward: The request for supplemental funding is \$51,778.00 for the PESH members to travel to Guam for teaching at a summer camp with a diverse population. The physical education and school health majors will be participating with the University of Guam from June 13 through July 5, 2011. The students will be working with the University of Guam Physical Education and Health students during the University of Guam's summer camp for local youth. They will be partnering with the University of Guam and the University is offering a room and board package for our students. PESH is working on multiple fund raisers and the students will take care of the rest of their own expenses, including weekends and spending money.
