#12046 CWU G.I.V.E. – Andrew Mason: The supplemental request is for \$23,000.00 for travel expenses to Nicaragua for 8 students to participate in the Growth International Volunteer Excursions on

July 9-23, 2012. The student volunteers will help build a vocational secondary school, teach English, implement large-scale fresh water systems and assist in conservation research for the endangered Hawksbill sea turtles. In addition to helping this volunteer organization, the students will gain a better awareness of cultural barriers and a broader global understanding. The students will bring this understanding back to the campus community and share their experiences of cultural differences to other CWU students through class presentations. They have done several fund raisers, and are going to academic senate and club senate, but do not know what will be awarded. At the next meeting of S&A Committee meeting this proposal will be discussed and voted on.

#12047 Applied Behavior Analysis (ABA) International Conference-Ginnie Hershbarger: The supplemental request is for \$1,484.80 for 5 students to travel to Seattle to the conference on May 25-28, 2012. The students have contributed \$50 each to attend this event as well as \$60.00 membership fee to reduce the cost of the conference registration fee. These students are graduate students and are extremely busy with research, internships and assistantships so have had no time for fundraising.
