Supplemental or Base Funding Requests – Presentations:

#12045 Esri International Conference – Isa Harrison: The supplemental request is for \$1,693.00 to travel to the Esri International User Conference in San Diego, California, on July 23-27, 2012. Ersi is the industry leader in Geographic Information Systems (GIS) software. Ms. Harrison plans on attending the Esri education user conference on Saturday and Sunday before the conference. This portion of the conference will address teaching GIS and how GIS can be used for different operations. The workshops are hands-on workshops, and will provide access, teaching materials and other educational resources. Since the University has the benefit of a large GIS lab, Isa will be able to share information about Central to others in attendance and the well-equipment computer lab at Central which will help recruit professionals and new students interested in this field of study. The committee will review this request and vote at the next meeting.

#12048 International Club Trip to Canada – Telmuun Bayarsaikham: The International Club is requesting \$967.10 in supplemental funds for their field trip to Vancouver, BC, Canada, on May 5-6, 2012 to study the cultural diversity from the point of view of International Students. There were 20 members who traveled and were faced with the cost for visas and other additional costs involved with international travel. The Committee reminded the International Club that this request is after the trip was taken and would be an exception to the S&A policy. Telmuun explained that the late request was caused by their request for funds to club senate and academic senate and they were waiting for their response and not knowing about the S&A Committee. This request will be voted on at the next S&A meeting.

#12049 NEHS/PESPH Senior Achievement Recognition Ceremony – Sarah Opdahl and Becky Pearson: The request is for \$250.00 in supplemental funds for the NEHS/PESPH Senior Achievement Recognition Ceremony on June 9, 2012. The ceremony will be held to celebrate the achievements of graduating seniors and encourage students to continue with their endeavors. They expect 300 guests including graduating seniors and their families. The funds will be used for incidentals and supplies like programs, paper goods, balloons and light refreshments.
