B. Supplemental Funding Requests – Voting:

#1502 – AORE National Conference - \$3,247.00: Students from the FCSG department are requesting funds for 10 students to attend the AORE National Conference to network with

professionals and look for jobs/internships. They hope to promote a positive and professional image of CWU at the conference. This conference will be held in Portland, OR. The event starts on Nov 12th and ends on Nov 14th.
