probably a good idea to keep a maximum number per quarter in mind. Not necessarily set a limit as Spring quarter is generally higher in requests than Fall.

MOTION: Eric Bennett made a motion to set the supplemental budget at \$250,000. Kane Lemasters seconded. Motion carried with 1 abstaining.

Discussion: Is there a penalty for increasing the budget later in the year? No. The committee should be mindful to stick with the budget that is set, since this is an open meeting the community will be aware of the budget that we set. Would it be beneficial to set a lower budget? This would probably not impact the requests.
