### A. Supplemental Funding Requests – Voting

i. #1939: International Women in Aviation Conference - \$2,731.00

Discussion: Pretty cool opportunity – it is good that they are not asking for a lot of students to attend but feel that limiting to only board members is not right. Board members do have buy in but would have liked to see them open it up to more people in the club. The people that are going are more committed students and said that they would bring it back to the club with presentations etc... Which may intrigue more students to be more involved. This does seem to be a beneficial event for the club and CWU.

# MOTION: Dane Gillian made a motion to approve supplemental funding request #1939 for \$2,731.00. Brandon Wear-Grimm seconded. Motion carried as amended with 2 abstaining. (\$2,131.00 excluding food)

Discussion: The request included food costs – we should exclude food from the motion to approve.

## AMENDMENT: Alex Harrington proposed an amendment to the motion to exclude food from the funding. Brandon Wear-Grimm seconded. Amendment carried with one abstaining.

Discussion: To be clear we are now approving the full amount of \$2,731.00 but excluding any food costs, so if airfare is higher than the quote they could request up to the funded amount.

## AMENDMENT: Eric Bennett proposed an amendment to the motion to exclude food and reduce the amount to \$2,131.00. Demetria Martinez seconded. Amendment carried with 2 abstaining.

ii. #1940: National ACS Conference - \$1,000.00

Discussion: Presentation was put together well the networking opportunities at the conference is a great reward for their work put into the research project. It was great to see women students involved in this field. It is great that they plan on looking for research opportunities and potential partners for other students that are not going.
