AVP 448 – Friendly amendment to course description to include 'of the training airplane.'

ETSC 343 – Prerequisite language clarified.

IT 359 and IT 461 – Reviewed for clarity and alignment.

KIN 480 – Student Learning Outcome #2 requires wording clarification or potential separation.

MUS 532 – Course description should better reflect student learning activities; similar language in MUS 232 and 432 noted.
