Faculty Fellows for Academic Service Learning Report 2015-2016

Report Submitted by: Sharryn Larsen Walker, June 2016

The CWU Academic Service Learning Faculty Fellows (ASL/FF) supports faculty in their endeavors to infuse academic service learning into courses. Since its inception, more than 80 CWU faculty have served as a Faculty Fellow. Previously, this group was supported by a Sphere of Distinction grant, and was under the direction of Dr. Jim Pappas and Dr. Jan Bowers. In June, 2014, the leadership for this group was handed to Dr. Sharryn Larsen Walker.

Included in this report is a description of the 2015-2016 goals and accomplishments of those goals; highlighted AS-L/FF projects and recognitions; 2015-2016 professional development opportunities; recommended AS-L/FF goals for 2016-2017 year; and the 2015-2016 agendas, minutes, and supporting documents.

Eighteen (18) CWU faculty served as Fellows during the 2015-2016 academic year. Six (6) Faculty Fellows began service in 2015, while 12 served as a Distinguished Faculty Fellow (more than one year service). The faculty included:

Campus Compact Participation-November 5 & 6, 2015

The WA State Campus Compact was held on the CWU campus on November 4 and 5. Several AS-L/FF members participated in one of the two days. The WA Campus Compact, through consensus participation of the attendees will be working toward assisting K-12 education in the next several legislative sessions and hopes to bring in other campus groups to assist in this effort.

CWU AS-L Website

The CWU AS-L website received updating and maintenance throughout the year. Terri Covey in Public Affairs assisted in the posting and organization of the website as items were sent to her. She was prompt in the requested maintenance and asked for feedback to ensure that the items were posted as requested. Terri's expertise is appreciated by the AS-L/FF. Survey about the Current Status of AS-L at CWU

Ian Loverro led an effort to survey CWU-FF in order to discover the current status of AS-L on campus. There was a low response, however, the following information from the November 30 meeting minutes is highlighted.

Ian shared that it appeared that those who responded to the survey wanted to be more fully supported. It was suggested that the information be used to write a press release about AS-L on the CWU campus and highlight those that have been including service learning in their courses. This press release could include highlighting former members, the website, and promote more AS-L on campus. Sharryn will write a draft and send it to the members for their input before sending it on to Public Relations.

2015-2016 Institutional Plan

The 2015-2016 Institutional Plan was completed at the February 1 meeting and is included in the attached documents.

Participation in INSLP-CEI

Several faculty members attended the INSLP-CEI at Whitworth University in Spokane, April 19-20. In its third year the CEI is sponsored by the universities and colleges located in the Inland Empire. This is the second year that CWU has been invited to participate in this Institute and it has shown to be an effective way to connect with the universities and colleges in Eastern

Washington who provide service learning on their campuses. Janet Spybrook, Jeff Snedeker, Sharryn Larsen Walker, Casey Mace, Glen Bach, Stefan Ward, and Mark Perez presented at the conference. The citations for those presentations is included in the attachments. Danielle Neal also attended the conference. The minutes from the May 2 meeting note the following comments about the Institute:

Janet shared that she enjoyed the conference and that it was a way to learn of other AS-L projects. She especially enjoyed the BOB talks and shared the project about Historic Spokane. Glen shared that he enjoyed learning about the Guam project by CWU professors. Mark Perez and Stefan Ward. Sharryn and Janet shared information about a session on publishing service learning. They distributed handouts and suggested that supporting presentations and publications on service-learning could be a goal for next year. It was suggested that Eric Cheney be contacted about assisting with this through Faculty Development. It was also suggested that Ross Watts from Whitworth and Patricia Chantrill from EWU be invited to give their presentation to CWU faculty.

Identify courses with AS-L component

The AS-L/FF identified courses that include an AS-L component and posted those items to the CWU AS-L website. The list of those courses is included as an attachment to this report.

Recognition for Service Learning

In an effort to recognize faculty for their commitment to the inclusion of AS-L in their courses, the FF refined the criteria for the selection process. Nominations were accepted and this year the CWU AS-L/FF recognized Dr. Mark Perez, Dr. Stefan Ward, and Mrs. Peggy Roberts for their support of AS-L in their courses. The announcement posted in *Central Today* is included in the attachments.

SOURCE Participation

In order to showcase student work, several members of the AS-L/FF participated in SOURCE. Glen Bach's Graphic Arts students shared the finalists' posters for the 2017 SOURCE. Tishra Beeson and Jeff Snedeker also had student work highlighted at SOURCE.

Highlighted ASL Projects/Recognitions

Each FF received a stipend as a way to support the ASL projects. ASL/FF received \$700, while ASL/DFF received \$500. Some of the highlighted ASL experiences from the 2015-2016 year include:

Dr. Janet Spybrook's SPED 433 *Preschool for Children with Developmental Delays* course created Literacy Embedded Play Centers (LEPC) for Bright Beginnings-Head Start Classroom. After the LEPC were set up, the teacher candidates observed and modified the centers based on the data collected.

Additionally, Dr. Spybrook successfully organized the *Compass to Campus* program between CWU and the Wapato School District. The purpose of this program is to introduce 5th grade students to higher education opportunities. More than 300 5th grade students came to CWU

for the day. CWU students served as mentors for the day, as well in 5th grade Wapato classrooms.

Dr. Cathrene Connery's EDLT 321-Teaching Children's Literature course co-hosted Family Literacy Nights with Mt. Stuart Elementary. The teacher candidates planned summer reading displays and created interactive centers in which the students and their families could interact.

Dr. Jeff Snedeker offered a UNIV 309 class entitled *Music Advocacy in Ellensburg*. The class took on individual service projects, including an instrument collection drive for the local school district.

David Bieloh's Graphic Design students collaborated with the students in Jennifer Green's Communications courses in the publication *HYPE*, the CWU student award-winning magazine.

The Distinguished Service Award for 2016-2018 was presented to Dr. Robert Holtfreter by Phi Kappa Phi.

2015-2016 Professional Development Opportunities

As previously mentioned, the AS-L/FF participated in several professional development opportunities. Several attended the Campus Compact that was held at CWU in November. It is hoped that the CWU AS-L/FF can participate in future Campus Compact events.

Additionally, eight members of the AS-L/FF attended the CEI at Whitworth in April. While there the participants attended sessions on including AS-L in courses; publishing opportunities of AS-L concerns; highlighted AS-L projects from universities and colleges in Eastern Washington. The keynote speakers were both from the Southern Poverty Law Center. The CEI will now be held every two years and the current AS-L/FF are interested in attending future sessions.

Combined Fund Drive Presentation- Drew Larsen and Meredith Carlsen presented about the CWU Combined Fund Drive. There is a list of charities on the site that might be of interest for faculty looking for AS-L sites.

Approval of Agenda- Jeff moved to approve the minutes; Teri seconded. Approved.

Approval of Minutes from May 4, 2015-Tishra moved to approve the minutes; Ian seconded. Approved.

Welcome and Introductions- The attendees introduced themselves.

Updates

- Budget-Sharryn shared that there were some issues accessing the budget because of the new
 university software. Linda Huber in the CEPS Dean's Office is the new administrative assistant
 for AS-L/FF. When she is able to access the budget, Sharryn will meet with her to determine how
 much the stipends for the year will be.
- Survey about the Current Status of AS-L at CWU-Ian Loverro
 - ➤ Review of Survey results- Because of the small return, Ian will send out a reminder to those who were previously sent the survey. The results will be discussed at the next meeting.
- Campus Compact-Sharryn shared that the WA Campus Compact will be held at CWU on November 5 and 6. The Provost's office will pay for Day 2 of the Institute. Faculty members need to email the Provost's Office to place the request. Should faculty want to attend the first day of the institute, it was suggested they use their professional development funds to finance it. It has been suggested that as many CWU Faculty attend as possible.

Business

Composition of the AS-L/FF- There has been interest from part-time and adjunct faculty who would like to join AS-L/FF. Sharryn checked into if a charter had ever existed which detailed who was eligible to join the group. According to the Provost, it is up to the AS-L/FF body to define the composition of the group. Glen reported that traditionally the composition of this group was FT/TT/T faculty. After discussion about the nature of the work in AS-L, this group came to consensus that FT/TT/FT/NTT would be included in the composition of the group. Sharryn will contact those who were interested and meet this criteria and invite them to join. It was also noted that there was not a representative from COS in AS-L/FF this year. It was suggested that Dr. Kurtz be contacted to see if there was an interesting faculty member.

Goal Areas for 2015-2016 Academic Year

The AS-L/FF faculty discussed goal areas for the 2015-2016 academic year:

- Campus Compact Participation: Encourage AS-L/FF to attend one or both days of the Faculty Networking/Institute to be held at CWU on November 5, 6.
- Survey about the current status of ASL at CWU-Review and publish the results of the Status of AS-L on the CWU campus.
- Evaluate the recognition for service learning that was begun in the 2014-2015 academic year. This included the stipends awarded to previous FF, as well as the recognition of former FF with an award. The evaluation criteria needs to be reviewed and updated should the AS-L/FF wish to continue with this endeavor
- SOURCE participation-SOURCE is working to include a strand of AS-L in its conference. Sharryn is working on a subcommittee that is creating a rubric for the evaluation of AS-L presentations submitted to SOURCE. She will share after the next meeting of this AdHoc group.
- AS-L Website-Work to keep the website current.
- Create an approval process for UNIV 109/309/509 courses for departments. In doing so, the AS-L/FF will know which departments are offering those courses. Additionally, it will be detailed as to how the course is funded and possible impacts on faculty WLU.
- Work to identify courses that have an AS-L component and advertise across campus. At this
 initial stage the AS-L/FF could work in conjunction with CLCE to have hours recognized on
 Leadership Transcript. This could be a beginning step toward identifying courses with an 'S"
 recognition.

 - ➤ The responses seemed to be down the middle, but there was some information that might be helpful in setting some direction for the AS-L/FF
 - > Based on the feedback, it was visible who felt supported.
 - ➤ There was a need for clarification between AS-L and CE. This was related to growing AS-L PD opportunities within courses. It was suggested that Eric Cheney be involved in helping that come to fruition.
 - ➤ There needs to be follow-up regarding AS-L presentations at SOURCE
 - > The validity of the data was questioned based on the number of respondents
 - ➤ Sharryn will meet with Ian in order to summarize data from the survey
