**Course Name: ADMG 445 - Applied IT Sustainability**

**Credits: 4 | Prerequisites: ADMG 285**

**COURSE DESCRIPTION:**

This course will address topics related to applied IT sustainability including life cycle assessment, life cycle cost analysis, and integrated bottom line principles.
