College in the High School Parent/Guardian Consent 2026-27

Parent/guardian consent is required for students registering with CWU for College in the High School (CiHS) courses. All students register online, and parent/guardian consent should be submitted in that platform. CWU CiHS acknowledges that online consent is not always possible. Parent/guardians can submit consent by filling and returning this form to the high school, or by calling the CiHS office to give consent verbally, if needed. If consent is not received before deadline, the student will not be enrolled with CWU. Giving consent one time will satisfy the requirement for a student who registers for multiple classes in one term.

*GRADES

*TUITION & FEES

Public School students have their course fees paid by the State of Washington for the 2026-27 school year. Private School students are still responsible for the \$60 per credit cost. Students and parents need to work with their school to determine and understand their financial obligations for taking a course(s). All private schools are invoiced by CWU. It is between the school and parent to determine payment. I also understand that if my student withdraws or fails a class, these fees are still applicable. I confirm the enrollment and accept the financial obligations of such.

*FERPA

I understand that my student is included in the University's FERPA (Family Educational Rights and Privacy Act) policy. The student's education records will be kept confidential.

*TRANSCRIPTS

I understand that to transfer these credits, the student must request their official CWU transcript be sent from the CWU Registrar to their college of choice. It is the receiving college's policy that determines if and how CWU credits will be received and applied.

*RIGHTS AND RESPONSIBILITIES

I understand that once my student is enrolled in the Central Washington University College in the High School program that they have the same rights and responsibilities as all CWU students.

*DROP/WITHDRAWAL/IMPORTANT DEADLINES
