Chair Updates – Introduced Emily Arras, the new committee student representative. Becky reported that the faculty development fellow position has gone back to the committee to discuss putting another name forward.

NWCCU – Bernadette reported on a visitation she was on recently. This institution was in their seven year review on institutional effectiveness, standard three. This institution was found to not be conducting annual assessment on their new Core (General Education). Bernadette expressed a concern about the mid-cycle evaluation that Central will be going through in 18 months. Currently we don't have much to present in the way of assessment of our General Education program. Central needs to document at least one or two terms of assessment this year. We need to document that the students are achieving, or not, the outcomes both at course and program level. Bernadette indicated that her position is being eliminated as of March 31, 2021. Not sure if Tom Henderson will continue in assessment. This will create a vacuum in the support the committee will receive around assessment.
